Degree College Pampore for introduction the new additional subjects viz: Public Administration and Statistics with an approved intake of 40 seats each from the current session (2019) subject to the fulfillment of the following conditions otherwise the university is vested with the authority to withdraw the same forthwith:*

1. Recruit necessary teaching faculty in respect of the newly introduced subjects before the commencement of the academic session;
2. Purchase sufficient No. of text as well as reference books related to these subjects together with the same No. of books pertaining to the subjects falling under Science/ Arts/ Commerce Stream which has been found inadequate as per the prescribed syllabi;
3. To create and develop a separate Science Block with all the necessary facilities;
4. Develop/ upgrade the Geology Lab with necessary equipment;

Note: In case the present plight of the college continues to exist related to Science subjects in terms of separate well developed practical labs and books, etc. it shall be liable for de-affiliation from the next session (2020).


